## CRITERIA AND BENEFITS FOR AFFILIATE, PROVISIONAL, AND COLLABORATIVE MEMBERSHIP CATEGORIES

## POLICY

Upon petition to the Board of Directors, majority approval at a meeting of the Assembly, and payment of dues as assessed by the Assembly, institutions meeting the criteria described above may become Affiliate, Provisional, or Collaborative members.

CRITERIA	Any department of veterinary science or department of comparative medicine which is independent of a school or college of veterinary medicine, is a unit of an accredited institution of higher learning and is located in the U.S. or Canada	Any college or school of veterinary medicine which grants the Doctor of Veterinary Medicine (DVM) degree or equivalent and is not accredited by or has not gained reasonable assurance from the COE	Any college or school of veterinary medicine outside of the U.S. and Canada which is recognized by its government as a professional school of veterinary medicine, and is not seeking COE accreditation

<sup>&</sup>lt;sup>1</sup> Provisional membership is granted with the expectation that non-accredited institutions are working towards accreditation by the COE. The term for Provisional membership is five (5) years. Membership may be extended for an additional 5 years upon demonstration that the institution is actively seeking accreditation. Upon accreditation, Provisional members are eligible to become Member Institutions.
